TERMS AND CONDITIONS (con't)

Copyright and Reproductions. The Videographer shall own the copyright of all images created and shall have the exclusive right to make reproductions. The Videographer shall only make reproductions for the Client or for the Videographer's portfolio, samples, self-promotions, entry in video contests or exhibitions, editorial use, or for display within or on the outside of the Videographer's studio. If the Videographer desires to make other uses, the Videographer shall not do so without first obtaining the written permission of the Client.

Failure to Perform. If the Videographer cannot perform this Agreement due to a fire or other casualty, strike, act of God, or other cause beyond the control of the parties, or due to Videographer's illness, then the Videographer shall return the deposit to the Client but shall have no further liability with respect to the Agreement. This limitation on liability shall also apply in the event the video materials are damaged in processing, lost through camera malfunction, lost in mail, or otherwise lost or damaged without fault on the part of the Videographer. In the event the Videographer fails to perform for any other reason, the Videographer shall not be liable for any amount in excess of the retail value of the Client's order.

Videographer. The Videographer may substitute another videographer to perform video services in the event of Videographer's illness or scheduling conflicts. In the event of such substitution, Videographer warrants that the videographer performing the video services shall be a competent professional.

TERMS AND CONDITIONS

Exclusive Videographer. The Videographer shall be the exclusive videographer retained by the Client for the purpose of videotaping the wedding. Family and friends of the Client shall be permitted to videotape as long as they shall not interfere with the Videographer's duties.

Deposit and Payment. The Client shall make a deposit to retain the Videographer to perform the services specified herein. At such a time as this order is completed, the deposit shall be applied to reduce the total cost and the Client shall pay the balance due. The Client's deposit of 60% is required at least 60 days before the date of service. The Client's deposit is forfeited if cancellation occurs within three weeks of the set date. The other 40% is required within two weeks after the date of service.

Videographic Materials. All video materials, including but not limited to digital videocassettes, S-VHS edit-masters, memory-stick images, shall be the exclusive property of the Videographer. The Videographer shall make copies of edit -masters at agreed upon cost.
